The Chair called on the Executive Secretary to read the proposed amendment to **Chapter 16**, **Section 2** of the *Rules Applying to Dog Shows* – Championships.

Ms. DiNardo: This amendment is to **Chapter 16, Section 2** of the *Rules Applying to Dog Shows* – Championships, which inserts verbiage to award championship points to a class dog awarded Reserve Best in Show. Points earned would be based on the highest number of points awarded in any breed from all groups excluding that from which Best in Show advanced.

This amendment was proposed by the Delegate Dog Show Rules Committee and brought forward with approval from the AKC Board of Directors.

A Brief Legislative Update

The battle is far from over but this is an encouraging result! As many of you know, on March 28, 2024, New Hampshire House Bill 1102 was tabled by a vote of 232 – 140, ending its consideration for the remainder of the legislative session.

New Hampshire HB 1102 included the following language:

"A person is guilty of a misdemeanor for a first offense and a class B felony of a second or subsequent offense; who...

(h) Sells an animal that has a birth deformity that causes suffering, such as brachycephaly, or the intentional breeding with the intent to sell, 2 individual animals with the same birth deformity that causes suffering, such as brachycephaly."

The heroes in the battle to defeat this legislation were Angela Ferrari of New Hampshire Dogs and Stacey Ober, AKC Government Relations Regional Manager, New England. Donna Albair represented the Boston Terrier Club of America. Donna's presence allowed the reading of our opposition statement into the public record. If you see Donna at one of the shows, please thank her.

The language used in New Hampshire comes directly from Europe and is championed here by the "Animal Rights" crowd. The Germans even coined a word for describing what we do: "Qualzacht." which means "torture breeding." They also define artificial insemination as a form of "mutilation."


The first battle was won, but we must take collective action to ensure we're ready to fight should HB 1102 reappear in New Hampshire or if bills of a similar nature appear elsewhere in the country. What can we do?

- Encourage BTCA membership. One of New Hampshire's lessons is that nothing succeeds like boots on the ground. Legislators are interested in hearing from their residents. We will need more foot soldiers in future battles.
- HSUS and PETA have infiltrated our schools and taught children that "adopt don't shop" is the way to go, and we need to undermine that message before we can move forward. Slogans and sayings work for the opposition; how can we counter them?
- Continue to encourage BOAS testing according to the Cambridge/OFA protocol. Make this a continuing feature at our National Specialty and promote the results.
- Our Health Committee must publish relevant information to help us prove the health and wellness of our breed.
- Communicate with state and national legislators. Let them know about your involvement in and commitment to pure-bred dogs. Angela Ferrari invited the committee chair who introduced HB 1102 to a dog show and had the legislator present the Best in Show rosette. We can all do similar things.
- We need to ensure that all our affiliate club members are aware of adverse legislation in their states and communities.

Those involved in this fight had a "post-mortem" meeting to discuss what went right and what we could do better next time. We met again last evening to continue the process. I will present an update at our next Board meeting and pledge to keep the BTCA front and center in future battles.

The key takeaway is that the brachycephalic breeds are under attack from the animal rights crowd. We need to do everything we can to save our breeds.

This video was sent to the Kennel Clubs of Germany, Italy, France, Holland, and Belgium along with a letter, in the appropriate language, stating that a well-bred Boston Terrier can excel in sports requiring speed and endurance.
